### <u>Teaching/Learning:</u>

Afterschool Program Presentation - Dick Stone

Board Member, Dick Stone presented an overview of the Afterschool Program which serves students from grades 3 – 6 at Simpson School, provides afterschool tutoring at the high school, and a summer art program. The program is in its' 12<sup>th</sup> year and is a partnership between Montesano Community Outreach (MCO) and the Montesano School District. The program is funded by grant donations. Mr. Stone described and shared the program activities, budget and the benefits to the students and the community.

# WA Kids - Craig Loucks

WA Kids: Principal, Craig Loucks presented a report on the WA Kids program as the State is now funding "All Day" Kindergarten. The program requires additional teacher training, skills inventory assessment in which additional data collection is provided to the State and parent orientation for the first three days of school. Discussions included the assessment pros and cons and the real benefit of having the parents visiting the classrooms and meeting the teachers.

**Business Action/Discussion Items:** 

**Wrestling Out of State Travel:** The wrestling team was invited to participate in an event in California. Funding provided by the Booster Club. The board is being asked to approve the out of state travel per policy requirements. No discussion; moved and seconded, motion carried.

**MCO – The Montesano Community Outreach Board:** The MCO board has requested to have school board approval for the continuation of the agreement between MCO and the district, as the original parties involved are no longer on the board. An Addendum to the agreement was drawn for signature approval. The actual agreement terms and conditions state that the renewal of the program is automatic. A motion was passed to approve the addendum to continue with the Afterschool Program; motion carried.

A motion was passed to approve the field turf donations as presented; motion carried.

### **Levy Discussion:**

Superintendent Winter handed out information regarding additional revenue the State is providing in the category of Materials, Supplies, and Operating Costs (MSOC). The increase was discussed in relation to levy dollars, levy lid and how the district should proceed with determining the levy amount. A levy study session was recommended to discuss in detail the district's levy options. Superintendent Winter stated he would follow up with board on a date. The board would need to meet prior to the November meeting as a resolution stating the amount of the levy would need to confirmed/approved at the November meeting.

**Kelsey Foundation Property:** The district was given approximately 10 acres of land from the Kelsey Foundation many years ago which resides on the West Satsop Cloquallum Rd. The property contains timber and wetlands. Superintendent Winter stated upon an assessment review, that due to some wetlands the property may only be worth about \$32,000.00. It has not been maintained and is used for dumping trash and poses a liability to the district. A neighboring property owner has shared concerns and is working with the district on some solutions. Superintendent Winter will continue to research the District's options and report back to the board.
